## 2023/2024 Bow View Ringette Association Cash Calendar Raffles

## RAFFLE RULES

- 1. All raffle tickets must be sold in the province of Alberta.
- 2. A total of 6,000 tickets are printed and available for sale at \$10.00 each.
- 3. Tickets will be sold via direct sales.
- 4. Tickets will be sold for cash or e-transfer if you are paying your team treasurer or raffle coordinator.
- 5. No refunds will be offered once a ticket has been purchased.
- 6. Raffle tickets shall not be sold to a person under 18 years of age.
  - a. Ticket sellers must advise ticket buyers not to write the name of a person under the age of 18 years of age on the ticket. If the name on the winning ticket proves to be a person under the age of 18 years of age, the prize will be awarded as per The Trustee Act.

- 7. Purchaser of raffle ticket(s) must have their name, phone number and e-mail legibly printed on each ticket.
- 8. In the event a winning ticket stub has more than one name on it, the first name listed shall be considered the Entrant and Bow View Ringette Association (BVRA) shall award the prize to that person. If that name is illegibly printed, then the second name will be awarded the prize. BVRA and the Alberta Gaming & Liquor Commission (AGLC) are not responsible for any disputes which may arise between the different individuals whose names appear on the ticket stub.
- 9. There are no restrictions on BVRA Board members, general members or their families with regard to purchasing tickets.
- 10. If 2,000 tickets are not sold a week before each draw, BVRA will request draw date extensions with AGLC.
- 11. All tickets must be received by BVRA prior to 8:00pm the night before each draw to be eligible for the draws.
- 12. The official prizes are as follows:
  - a. 5 individual prizes of \$1,000
  - b. 2 prizes of \$2,500
  - c. 1 prize of \$5,000

Total cash prizes available is \$15,000.

13. All draws will take place at a current board member's home or an arena with a minimum of two board members present.

The scheduled draw dates and corresponding prize amounts will be as follows:

- Friday, November 10th, 2023 5 individual prizes of \$1,000
- Friday, December 15th, 2023 2 prizes of \$2,500
- Friday, January 19th, 2024 1 grand prize of \$5,000

- 14. The draw will be recorded as one (1) ticket is drawn from a transparent or mesh constructed draw barrel of which tickets can be seen from the outside.
- 15. The winning ticket will be drawn manually by an individual who does not hold a ticket or have an interest in the draw, in a random manner and according to AGLC requirements, including:
  - a. Only the person making the draw will put their arm into the draw barrel.
  - b. They will have no clothing on their arm below their elbow.
  - c. They will exhibit their draw arm and both sides of their open hand to the draw witnesses immediately prior to making the draw.
  - d. When selecting the winning tickets, the person making the draw shall look away from the draw barrel and in the direction of the witnesses.
- 16. At least 2 members of the Association (including one Executive member of the Board of Directors) and one member of the General Public will be present to witness the draw.
- 17. Winning tickets will be recorded and winners to be contacted shortly after the draw is complete.
- 18. The winners do not have to be present to win the prize.
- 19. The winners must present valid identification to BVRA to claim their prize.
- 20. If a winner cannot be located within one (1) year from the draw date BVRA will donate the prize back to itself, or to another charitable association, based on the approval of the AGLC.
- 21. The name of the winner will be available after draw date and will be posted on BVRA's website <a href="https://www.bowviewringette.com">www.bowviewringette.com</a> and social media platforms.
- 22. In the event that BVRA becomes aware of tickets being stolen or misplaced, BVRA shall notify AGLC immediately and file a Discrepancy Report within three (3) days.
  - a. If the ticket(s) were lost or stolen before they were sold, BVRA shall advertise where the tickets were lost or stolen and that these tickets will not form part of the draw and will not be eligible for prizes. At the location of the draw(s) prior to the draw, BVRA will announce the lost or stolen tickets and that they will not form part of the draw.
  - b. If the ticket(s) were lost or stolen after they were sold, BVRA shall advertise that tickets with the affected serial numbers were lost or stolen and will not form part of the draw, and anyone holding such a ticket should contact BVRA so that, if required, another ticket can be issued.
- 23. Any suspected cheating or other irregularities shall be reported immediately to the AGLC at: 1-800-742-7818 (24 hours).
- 24. General: By accepting the prize, winners agree to hold Sponsors, its Agencies, Affiliates, Subsidiaries, Agents, Advertising and Promotion Agencies, and anyone else involved in the development, production or handling of the raffle and their respective Directors, Officers, Employees, Volunteers and assigns, harmless against any and all claims and liability arising out of use of prize. Decisions are final on all matters relating to this raffle. By participating in the raffle, entrants agree to be bound by the Official Raffle Rules and the decisions of BVRA.
